**CONSTITUTION OF ASHOKA EDUCATION TRAINING & RESEARCH INSTITUTE, KRISHNA NAGAR, JAMMU.**

1. **Name of the Society :-**  
The name of the society shall be Ashoka Education Training & Research Institute.
2. **Registered Office**  
The registered Office of the society shall be situated at Krishna Nagar Jammu.
3. **Area of Operation**  
The society shall operate for the setting up of the educational Institutions, Professional College, Hospitals and other Institutions to uplift the living standards of the people in state of Jammu and Kashmir.
4. **Aims and objects**  
Broad aims and objects for which the society is established are as under.
  - i. To promote the educational standard on modern and scientific lines.
  - ii. To set and manage schools, colleges including professional colleges, polytechnics, Research centres, Training Institutions, specialized departments or centres for publications, guidance and counselling, documentation, Health nutrition, medical education, continuing vocational and distance education, adult arts and cultural propagation, physical education, rural development, special welfare, social science, community education utilizing both formal and non formal techniques according to the emerging trends.
  - iii. To train the basic level health functionaries especially among rural population which could implement MCH and family welfare programs successfully.
  - iv. To promote the cause of education, learning, research and training amongst the people belonging to Scheduled caste/backward classes, Scheduled Tribes, other economically weaker sections of the society and people dwelling in far areas of the state of Jammu and Kashmir.
  - v. To establish Charitable Hospital/and MCH and family welfare centre and PHCs in the state of Jammu and Kashmir for providing medical facilities to the needy population.
  - vi. To create awareness among the people especially women so as to enable them to enlighten them in the field of implementation of family welfare programmes and population control.
  - vii. To reduce unemployment by imparting them training which shall enable them to be self supporting to the people of India and abroad. People from abroad shall be registered only to those which will give donation to the society.
  - viii. To undertake preparation and publication of written material of all kinds including journals and other periodicals or preparation and dissemination of material for other mass media that will subserve the objects of the society.
  - ix. To affiliate itself to or to get affiliated to societies/organizations seeking the objectives similar to those of the society so that the programme and activities resulting in the achievement of those objectives may be more effectively coordinated.
  - x. To raise all such funds as are necessary and adequate for implementing the programme and activities of the society and to control and regulate the disbursement of such funds.

- XI To receive in aid , subsidies, Development aids, donation Etc. from the central / state Govt. Individual or other bodies Weather established within or out side the country and for purpose to enter into requisite agreement under law xii . To borrow money for carrying out the objectives of the society from the bank and other bodies corporate weather or not a society.
- XII To open account both current and saving and deposit funds in the form of fixed deposits and in other forms with scheduled bank and post offices.
- XIII To invest money of the society which is not immediately required on such securities and shares Etc. and in such manner as may from time to time determined by the society
- XIV To Provide Financial and other aids to the Institutions/ Organizations Engaged in the Promotion of the health education combined with academic/ scientific education.
- XV To defray all expenses of and incidental to the formation and in-corporation of the society out funds of the society.
- XVI To Recruit and deobogy necessary teaching and administrative staff for all the institutions established and run by the society for the realization of its objectives.
- XVII To Pay the Salaries and Conveyance allowance extra to its employees or Ex- employees of the society and those associated with the institutions set up by it in accordance with the bye - Laws in the regard.
- XVIII Society and to dispose property/ not required for its purpose.
- XVIII ~~The members of the society passed a resolution in which authorization to any member can uphold the property for sale, Purchase, Mortgage and lease.~~
- XIX To formulate rules for governing the different institution and implem itir 3 the objects of the society.
- XX To Formulate rules for governing the different institutions and implementing the cbjects of the society.
- XXI The undertake all such activities that not specially mentioned in aims and objectives listed above but will help the masses to attain the highest level of health and medical education.

5. Provisions for dissolution of society and adjustment of their affairs

If upon the dissolution of the society, there remains after the satisfaction of all its debts and liabilities, and property what so ever, the same shall not be paid to or disbursed among the members of the society, are any of them but shall be given to some other society, to be determined by the votes of not less than three fifth of the life members in accordance with the provisions contained in section 11 and 12 of the J&K registration Act, 1998 (1941 A.D.)

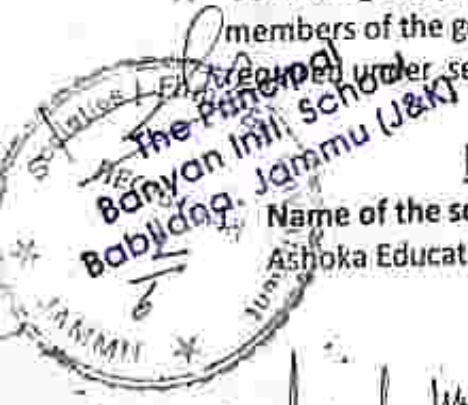
6. Jurisdiction : For all legal problems, Jurisdiction shall be at courts of Jammu Only.

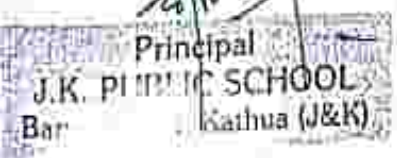

### Admission to and Qualification for Membership :-

Any person shall be eligible to be members of the society provided

a.

He is citizen of India.

b.

His written application for the membership has been approved by a majority of the Executive Committee.

c.

His age is more than 18 Years.

d.

Is not a member of any communal organization.

e.

It interested in the programme of specified above.

f.

Every ordinary members on admission shall pay Rs. 10/- as admission fee which shall not be refunded in any case.

### Membership Register

That the secretary, general secretary of the society shall maintain a complete and proper register of name & addresses of the society Members. The register shall be open of inspection to all concerned member of the society.

### Cancellation of Membership.

A person ceases to be members

On Death

When his resignation is accepted by the president.

The president reserves the right to expel/terminate any member of the society, after giving him/her a reasonable opportunity to submit his/her explanation, without assigning any reason thereof.

If he is convicted of a criminal offence involving moral.

If he intentionally acts in any manner likely to injure the reputation/credit of the society or does his work below the standard required of the Executive Committee or fails to observe proper discipline with regard to the work of the society.

### 7. Rights and privillages of Members

- a. Every member shall have an equal right to vote at the annual general body meeting and to enjoy and participation in the activities of the society.
- b. Any member not less that 50% of the members shall have a right to regulation a meeting of the General Body provided he/she given 20 days notice to the secretary/Gen. secretary of the society. The general Secretary shall after convince a meeting within 30 days.

- f. All business discuss or decided at a General meeting shall be recorded in a minutes Book which shall be signed by the president of the meeting.

### 9. Notice of the meeting.

- a. The meeting if general body shall be held once a year and special meeting may convened with clear notice for 15 days. The quorum of the general Body will be 1/3 of the total membership.
- b. The meeting of the executive shall be held as & when it is deemed necessary i.e. emergency meeting may called at a short notice.

12. **Powers & duties of office Bearer**

1. **President :-** The President shall be Chief Executive of the society and shall be Ex-official member of all the sub committee of the society. He shall preside over the meeting of the society.
2. **Vice President :-** In the absence of the President, the Sr. Vice president will perform all duties/functions of the president. He will act as officiating president till new president is elected.
3. **Secretary :-** He will be Incharge of the day today function of the society and maintain full record of all the proceeding of the meeting of the society. He may also represent the society at various forms, functions, meeting etc.
4. **Treasure :-** The treasure will maintain the Accounts of the Society and wil also be mainly responsible for the collection of the funds.
5. **Sources of Income & Utilization Of Funds :-** The Society shall collect the subscription and funds from the concerned members from donations, Grant-in-Aid raising of loans organizing charity shows. The funds of the society as mentioned in the Aims & Objectives of the society.
6. **Financial Year :-** The financial year, shall be 1st April to 31st March.
7. **Audit of Accounts :-** The Accounts of Society shall be audited annually by the Auditor. The Executive Committee shall appoint the Auditor for the said purpose in this behalf.
8. **Operation Of Bank Accounts :-** The accounts shall be opened in any Nationalized Bank in the name of the society and shall be operated by the Secretary duly authorized by committee.
9. **Legal Proceedings :-** The Society may sue or be used in the name of the Secretary as per provision Registration Act 1860, as application to the State of Jammu and Kashmir.
10. **Interpretation of Rules**  
The Executive Committee shall be final authority for intpreting these rules.
11. **Essential Certificate**
