**Sub: Fixation and Regulation of fee of J. K. Public School, Barwal Morh, National Highway, Kathua.**

**J. K. Public School, Barwal Morh, National Highway, Kathua** submitted the file for fixation and regulation of fee structure of the School, which has been registered in this office under No. **FFRC/FF/2021/Kat/34**.

The fee structure of the School has not been determined, fixed and regulated till date. The record shows that as on 31.03.2020, the School had surplus of 15.2%. The surplus of 10-15% is a reasonable surplus.

The **Annual Fee** is being charged and collected by the School @ Rs.7000/-. On careful consideration of the entire material placed on record by the School management, it is deemed appropriate and reasonable to maintain and regulate the **Annual Fee @ Rs.7000/-** for the academic years **2021-22, 2022-23 & 2023-24**.

On due consideration of the material produced by the School management and after considering all the relevant factors which govern the subject and the trend in expenditure incurred by the School, the Committee finds it just and proper to fix and regulate the **Tuition Fee** of the School as under:




